This serves to advise the general public and our valued clients that consistent with the National Gazette No.231 dated 27 March 2019 on Migration Fees (Amendment) 2019, effective from **1 November 2019** all visa fees will be charged in United States Dollars (USD) conversions and all Migration Service Fees can be paid via our new online payment gateway available on our website: www.ica.gov.pg

- 4 Lodge applications with copy of receipt
